3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)

Junior, 6 Months & Under 9 Months; Junior, 9 Months & Under 12 Months; Senior, 12 Months & Under 15 Months; Senior, 15 Months & Under 18 Months.

CLASSIFICATION

REGULAR CLASSES:

The following classes will be provided for both dogs and bitches: Puppy, 6 Months & Under 9 Months; Puppy, 9 Months & Under 12 Months; 12-15 Months, 15-18 Months; Novice; Bred-by-Exhibitor; American-Bred; Open; Winners; Best of Breed Competition.

Judges Are Not Required To Wait For Dogs. They will adhere as closely as practicable to the Judging Program. **The owner or handler of each dog is solely responsible for having it ready at ringside when it is to be judged.** IWANE and the Show Secretary have no obligation or responsibility to provide service through a public address system or other means for the purpose of calling or locating dogs that are not brought into the ring when required.

This event may be cancelled due to extremes in weather or other conditions considered to be deleterious to the health and safety of dogs, exhibitors, judges and fanciers. No refund of entries will be made in such case.

The Show Committee has designated the entire headquarters hotel and hotel grounds as the show site. An Event Committee may be held for any hotel complaint including, but not limited to, failure to clean up after your dog and destruction of hotel property.

The show giving Club, the Show Secretary, their agents, employees, etc. assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assume no responsibility for injury to children.

All trophies must be claimed before the closing of the show. None will be mailed.

The Club reserves the right to substitute a prize of equal or greater value.

The show-giving club does not agree to arbitrate claims as set forth on the official AKC entry form for this event.

NOTICE TO EXHIBITORS – SHOW REGULATIONS

Closing Date for Entries is 8:00 PM on Wednesday, June 28, 2017 after which time entries cannot be accepted, cancelled or changed, except as provided for in the AKC "Rules Applying to Dog Shows". After the closing date, NO REFUNDS WILL BE GIVEN FOR ANY REASON unless provided for in AKC's "Rules Applying To Dog Shows".

All Entries are to be Mailed with Fees to Patricia Reilley, IWANE Show Secretary, 3940 Nottingham Ave., Youngstown, OH 44511. Acknowledgement of entries will be made as soon as practicable after closing by mail with printed confirmations of entry.

Entries Not On Official AKC Entry Forms and photocopies of entry forms without the Agreement and Rules are not acceptable.

No Entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Entries will not be accepted without fees or signatures.

Declination of Entries. The Irish Wolfhound Association of New England, Inc. may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other cause and no one shall have any claim or recourse against the Irish Wolfhound Association of New England, Inc. or any official thereof.

Canadian Exhibitors must submit entries with checks drawn on US accounts or payable in US funds, or with international money orders in U.S. funds.

Returned Checks do not constitute a valid entry fee. The Show Secretary will add a collection fee to the amount of each returned check.

Errors on Entry Forms: Owners are responsible for errors in making out entry forms, whoever may make such errors and **no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.**

No Refund for Duplicate Entries. We will make every effort to find all duplicate entries, but if an entry has been processed, no refund will be made.

Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge or barred from competition by action of Show Committee. If because of riots, civil disturbance or other acts or conditions beyond the control of the Club or the Show Secretary it is impossible to open or to complete the show, no refund of entry fee will be made.

The Show Will Be Open from 7 A.M. to 7 P.M. each day, Sunday-Monday, July 30-31, 2017.

Dogs May Arrive any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.

Consult Judging Program for time of judging.

NON-REGULAR (ADDITIONAL) CLASSES Involving Single Dog Entries

VETERAN DOG CLASS – A Class for Dogs six (6) years or older.

VETERAN BITCH CLASS – A Class for Bitches six (6) years or older.

BEST HEAD and BEST GAIT: Upon the completion of Best of Breed competition there will be two non-regular AKC classes, **Best Gait** and **Best Head**. Entry fee for each of these two non-regular classes is \$10.00. Use the **"additional classes"** box on the entry form to enter.

NON-REGULAR (ADDITIONAL) CLASSES Involving Multiple Dog Entries

As the judge's decision in the Non-Regular Classes involving Multiple Dog Entries is based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won these classes.

STUD DOG CLASS – For Stud Dog and two or more of their Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. The Stud Dog may be entered separately in one of the regular classes, or if a Champion of Record in Best of Breed Competition, but **MUST** be entered in the Stud Dog Class, the Get **MUST** be entered in one of the regular classes. The Stud Dog shall be considered as one entry and requires one entry fee, this being the regular fee plus the additional class fee if the Stud Dog is entered in another class. The Stud Dog must be shown in the ring with the Get. The class will be judged on the merits of the Get.

BROOD BITCH CLASS – Same as for the Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get.

BRACE CLASS – Two dogs of the same recognized breed or variety that are similar in appearance, performing in unison, and presented by a maximum of two handlers. Both dogs competing in brace competition must have at least one common owner.

TEAM CLASS – Four dogs of the same recognized breed or variety that are similar in appearance, performing in unison, and presented by a maximum of four handlers. All dogs competing in team competition must have at least one common owner.
